

A BIBLIOGRAPHY OF MATERIALS ON NIGERIAN LAW

PUBLISHED IN NIGERIA

Introduction

Even for those of us working in Nigeria, it is not easy to keep track of work published there on legal topics. The task is necessarily even greater for those endeavouring to keep abreast of Nigerian law from outside the country. Like the law reports,¹ journals are published somewhat sporadically, and few of them are indexed in the Index to Foreign Legal Periodicals. This is an endeavour at least partially to fill the gap. It was originally conceived as a bibliography of journal articles only. However, as this led naturally to collections of essays and to pamphlets, it seemed preferable to encompass all types of material of Nigerian legal interest published in Nigeria.

Apart from the fish which will escape any net, the following have been deliberately omitted: articles containing no Nigerian material (except in the section on International Law); articles by students unless of unusual interest; notes and comments of only one or two pages. The plan of the bibliography is as follows:

Section A Books and monographs etc. published in Nigeria including mimeographed collections of cases and materials. (The latter often circulate only in their university of origin and so some may well have escaped my attention.)

Section B Collections of essays and lectures, and conference reports, of which the contents, so far as they relate to Nigerian law, are individually listed in Section D.

Section C Periodicals of which the contents so far as relevant are listed in Section D. Most of these could be described as legal periodicals, but some are primarily concerned with other disciplines and others are fairly general in scope.
