

J.S.D. THESES ON AFRICAN LAW TOPICS

The Editors

The following bibliography covers the years 1960 through 1976 and covers all law schools in the United States and Canada that offer the J.S.D. degree. Our intention was to produce an exhaustive bibliography, and all law schools listed in the AALS Directory of Law Teachers as offering the J.S.D. degree, as well as some others that we suspected might in fact offer it, were contacted. Nonetheless, the chaos in which records of J.S.D. theses, and even the theses themselves, are kept at most institutions makes it impossible for us to guarantee the completeness of this bibliography. The same condition makes it impossible to guarantee that all the theses listed here are in fact available at the institutions responsible for them. Most seem to be kept in the law libraries of the institutions concerned, but since each school catalogues theses in an idiosyncratic way, we suggest that anyone looking for a thesis seek the assistance of a reference librarian.
